Application Questions

What are the admissions requirements for the program?

The ideal candidate has a Master's or undergraduate degree in Psychology or Social Science and a strong interest in understanding and promoting resilient development. A Master's degree and related research experience are recommended. Is there a cut off test score or GPA?

When should I apply?

Applications open up in the fall. Online applications and all supplemental materials must be received by the deadline to be guaranteed faculty review.

Part-time is not available for ISHD doctoral students.

Program of Study Questions

What is the goal of the program?

The goal of the Interdisciplinary Studies in Human Development (ISHD) doctoral program is to provide students with a strong foundation in developmental theory and research from interdisciplinary and life-span perspectives. The program prepares students for careers in research and tenure-track positions in academia. It is not designed primarily for applied careers in clinical psychology. The program offers opportunities for students to explore social, emotional,

and cognitive aspects of human development from infancy to adulthood. Students learn about the processes of developmental growth and change in educational and sociocultural contexts. Students receive training for high quality research in human development using rigorous methodologies through participating in research projects with faculty mentors and coursework. In addition, students are encouraged to engage in collaborative research with faculty and students across areas and departments.

Who are the faculty advisors?

All students are paired with a member of the standing faculty in a "mentorship" or "apprentice" model for the duration of their studies. The ISHD Ph.D. program is highly flexible inasmuch as doctoral students can tailor their studies to suit their interests IF it also fits closely with the research interests of one or more of the members of the standing faculty. Successful applicants are those who are able to demonstrate how their research interests will dovetail with a particular faculty member's research portfolio. The faculty advisors are Drs. Xinyin Chen, Doug Frye, Mike Nakkula, Howard Stevenson, and Dan Wagner. Other faculty members can serve on dissertation committees but cannot act as primary advisors.

What are the required courses?

The Ph.D. in ISHD requires 20 courses. Each student follows an individualized planned program of study which is determined by the student with the primary faculty advisor. Students are encouraged to choose appropriate courses with affiliated faculty in departments such as sociology, psychology, pediatrics, or others, in accordance with the student's own emerging research interests and suggestions from faculty advisors. Students can take graduate-level (500+) courses at any of the schools across the University of Pennsylvania, as long they have permission for the course from the department in which the course is housed. Students check with their advisor on their course selections.

What is the typical course load?

Students receive full tuition for up to eight courses for the academic year. Students typically take 4 courses in the fall and 4 courses in the spring.

Are there other requirements in addition to the 20 courses?

Students are required to do research apprenticeships 20 hours per week during the academic year, working with faculty on their research. The explicit goal of the apprenticeship is to publish, initially co-authored but building toward increasingly more independent work.

What are the milestones of the program?

Students are expected to complete the Ph.D. comprehensive examination, write and defend dissertation proposal, and write and defend their dissertation. For more information, please see the Ph.D. degree requirements.

What is the typical length of the program?

The length of the program depends on the amount of time it takes the student to complete the 20 courses and milestones. Since it is possible to transfer up to 8 courses from the master's degree with the advisor's approval, some students complete their coursework sooner than others. However, it typically takes a student 2.5 years to complete their coursework. Students then go on to complete the milestones mentioned above. The University's maximum time limit for completion is ten years after matriculation.

Funding Questions

What kind of support do ISHD doctoral students receive?

Our doctoral students receive four years of tuition, stipend, and health care support.

Can doctoral students hold any other employment while in the program?

Doctoral students are expected to devote their full attention to graduate study and may not hold any other employment, either internal or external to the University, while receiving funding.
