## Education Policy – M.S.Ed. Planned Program of Study (2016-17)

<u>10 course units</u> (minimum) along with successful completion of the Education Policy Research Practicum are required for the M.S.Ed. degree in Education Policy. All degree candidates must maintain a minimum cumulative GPA of 3.0. Courses cannot count towards two requirements, with the exception of the distribution requirement.

This form is to be completed by the student in consultation with an advisor in the Education Policy division at the Penn Graduate School of Education. A copy of this signed planned program of study form must be on file in the divisional office.
